### What is a Student Trustee?

### "Award Winning Students' Union"

We are proud to have received several awards and recognitions for our work with students, including Students' Union of the Year at both the NUS Awards and Educate North & UK Leadership Awards in 2017. We have also achieved 'Excellent' status in the NUS Green Impact Students' Unions, achieved NUS Quality Student's Union status, received Gold in Best Bar None, and won this year's Varsity against York St John University.













### **Our Commitment to Sustainability**

We are committed to improving our sustainability as an organisation because we know it's an issue that students are passionate about. Our SMART sustainability plan sets out how we will work with our students and the wider community, whilst collaborating with the University, the Vice President, and Part-Time Sustainability Office, have worked to reduce our collective carbon footprint through campaigns such as Responsible Futures, building and launching outdoor areas for growing veg and flowers, achieving Green Impact Excellent, and proactively reducing our plastic waste.

We champion sustainability here at LTSU and our Vice President leads on this through their role at the Union, through campaigns, and by holding the University to account to set a precedent moving forward. Our full-time and part-time Officers attend sustainability bootcamps to help them to understand wider areas affecting sustainability and aid them to better their campaigns to get results. LTSU also understands and commits to showing our negative impacts on the environment to our students and are continually trying to reduce these.





LTSU is a registered charity, democratically led by its student members through two annually elected Sabbatical Officers, the President and Vice- President. These two roles are supported by a small staff team who are experts in their fields, together they can sustain an environment for students to reach their potential

### **Finance and Funding**

LTSU operates independently with its financial status and is funded by the University through a block grant of just over £180k. This is supplemented by some additional funding for sports and activities, as well as self-generated income through our commercial outlets and events, which takes our total revenue to around £360k. This enables us to deliver opportunities and services for students.

### **Student Council**

Every year, students are elected to over 200 roles across the Union, including the Student Council. The Student Council provides the democratic, political leadership of the organisation and is responsible for representing the views of students.

### **Trustee Board**

As a charity, we are led by nine trustees made up of two elected Sabbatical Officers, three student trustees, and up to four external trustees. They are the first and final decision- making body of the Union.

External trustees on the Board have a background in Mental Health, students studying to become teachers, Higher Education policy, and significant experience in campaigning and good practice within Students' Unions. They are joined by three student trustees and the two sabbatical officers

We believe that everyone is unique and are committed to ensuring our workforce is an inclusive community that reflects the diversity of the world and our members. About Us

Every year, LTSU holds an annual Election in which students can stand for a range of part-time (volunteer) roles, and two (paid) roles. Together, our Elected Officers represent the voices of Trinity students.

Our full-time Sabbatical Officers for 2022-23 are:

### **President - Kelsey Howard-Matthews**



The President is our highest Elected student officer and is ultimately in charge of the SU. They are the figurehead of LTSU and therefore are the key contact between the University and external organisation's such as the National Union of Students (NUS). The President leads on academic matters, working closely with staff on the Course Reps and School Reps systems. They also chair the Board of Trustees; line manage the General Manager and are a Governor on the Board of Governors.

### Vice President - Kieran Clarke



The role of the Vice-President is to be the lead officer to promote and protect student communities at Leeds Trinity, ensuring effective welfare support is provided. They work with the Advice Centre on issues like mental health support and other wellbeing matters, ensuring that students know where they can get support and advice from. They also work closely with the staff team on ensuring there is a wide range of societies and events. The Vice President is a member of the Union Trustee Board, Student Council, and Student Executive Committee, and chairs the Student Activities Committee.

### **Eligibility**

Leeds Trinity Students' Union is a charity registered with The Charity Commission, and must comply with Charity Law. There are requirements about who can, and cannot be a Trustee. To read the law in full please go to https://www.gov.uk/guidance/automatic-disqualification-rules-for-charity-trustees-and-charity-senior-positions

You are not allowed to be a trustee if you:

- Are under 18 years of age
- Are on the Sex Offenders' Register
- Have an unspent conviction (see below for details) for an offence involving
- deception or dishonesty
- terrorist offences
- money laundering
- bribery
- misconduct in public office, perjury, perverting the course of justice
- contravention of certain preventative Orders of the Charity Commission (s.77 of the Charities Act 2011)
- attempting, aiding, or abetting these offences
- Have been found in contempt of court
- Are within designation under specific anti-terrorist legislation
- Have been found guilty by the High court of disobeying a Commission order or direction
- Have been removed from:
  - trusteeship, or as an officer, agent, or employee of a charity by the Court or the Commission for misconduct or mismanagement
  - a position of management or control of a charity in Scotland for mismanagement or misconduct
- Have been subject to a disqualification order under the Company Directors
   Disqualification Act 1986
- Have undergone undischarged bankruptcy
- Have a composition or arrangement with creditors which includes an individual voluntary arrangement (IVA), and is currently on the Insolvency Service Register

### **Purpose of the Role**

You have collective authority and responsibility to develop policies, procedures, and regulations for the operating of Leeds Trinity Students' Union. You monitor the Union's overall performance against the operating and strategic plan. You also interpret the constitution as required. You are responsible for fully understanding our Constitution and Byelaws. You will have an awareness of the day-to-day activities of the organisation and provide sound assistance to the General Manager through your role.

You will get to make a difference to over 7,500 students' lives at Leeds Trinity University ensuring we become a high performing, relevant Students' Union that represents, supports, and builds relevant digital and physical communities for our students. You will be provided with training on being a trustee, be invited to major student engagement and celebration events across the year and to an annual trustee residential that will focus on developing both the Board and the organization

### **Time Commitment**

The Board typically meet seven times a year usually on Thursday evenings from 6pm online. One of the meetings is an extended training weekend day within a comfortable distance from Horsforth. This is an unpaid voluntary role, but reasonable travel expenses will be reimbursed.
