<u>Item 4 – Action Tracker</u>

Council reviewed the attendance log

ZS updated council on the Free Periods campaign and explained discussions were ongoing with the University over producing a sustainable funding model. Explained that the SU would attempt to begin distribution from StUdio

CD updated council on interaction he had had over their plans to better advertise assistive technology

JS expressed a desire to attend the next meeting Chris had with the library on this issue

CD talked about his work on the Rainbow Lace campaign and his meeting with the LGBT+ Officer
